Crime and Traffic Campaigns/Initiatives:	There were 9 Collisions in St. Marys in May (9 Property Damage, 0 Personal Injury).
	There were 2 RIDE programs conducted in St. Marys in May yielding no charges or tests.
	The Canada Road Safety Week traffic campaign occurred with police laying 219 speeding charges for the county, along with 15 seatbelt charges, 11 fail to yield (or stop sign) charges and 4 impaired/over 80 charges.
Public Education Campaigns:	PUBLIC EDUCATION & CAMPAIGNS: In May a bike rodeo was conducted in conjunction with the Downie Optimist Club. This was held in St. Marys Pyramid Centre on May 27, 2017. 107 children participated in this event and 37 new helmets were distributed by the Brain and Mind Matters Community Fund to children requiring them. These helmets were donated by Home Hardware. OPP auxiliary members participated in both planning and delivery of this event and played a key role to its organization and success.
	PC Melnychuk also completed media releases for the Town of St. Marys Emergency Services exercise that took place on May 31, 2017. Perth County OPP also ensured that messaging for this event was distributed through both traditional (radio, TV and print) and social media formats (Facebook, Twitter).

Community Mobilization Officer:	In the month of May, PC Dekoning attended numerous meetings and functions in his role as the Community Mobilization and Engagement Officer. It is an important part of his job to continue to network with community partners in order to make the appropriate referrals when dealing with prolific subjects.	
	PC Dekoning attended a Canadian Police Newcomer's Engagement meeting at OPP Headquarters in Orillia. The meeting discussed the role of police in the recent Syrian Refugee crisis. PC Dekoning also attended an OPP Mental Health Strategy meeting at Regional Headquarters in London. The meeting discussed the direction of the OPP moving forward when dealing with mental health.	
	PC Dekoning has completed the Kid's Program with a St Mary's youth who has mental health and behavioral issues. The youth was engaged and enjoyed the program and received a certificate upon completion.	
	PC Dekoning has been making contacts with a number of St Marys residents who are experiencing mental health and addiction issues. The subjects are often transient so it can be a challenge connecting with them to ascertain if they are receptive to receiving assistance.

Ongoing until 20Jun1710 hours of patrol registered county-wide through the end of May</li> <li>17-405 Patrols requested in conjunction with Stop &amp; Look Campaign (Stop Signs). Ran from June 5th-11<sup>th</sup> with a total of 91.75 hours dedicated to this initiative and 41 charges laid.</li> </ul>
<ul> <li>May 8<sup>th</sup> Sgt Lobb met with members of the BIA and provided advice on robbery prevention. The Auxiliary unit will meet with business owners in the near future to complete Safeguard Ontario safety planning.</li> <li>May 31<sup>st</sup> Community Emergency Disaster Planning Day. This was well-attended and well-received within the community. Numerous emergency personnel from various services were in attendance and worked together to ensure a safe resolution to the exercise. A debriefing session was held afterwards.</li> </ul>

# **Noteworthy Occurrences**

- There was a theft of a kayak from Canadian Tire. This is the second such theft in three weeks from this location.
- On May 31st, the OPP utilized a vehicle equipped with the Satellite Technology Apprehension Response (STAR) system after receiving a call from the London Police Service who were following a pick-up truck that was towing a trailer and refused to stop. OPP officers were able to work with the London Police Service and receive updated information as to the location of the wanted vehicle as it continued to travel eastbound on Highway 401, eventually exiting at Drumbo Road. The STAR equipped OPP vehicle continued to proceed to the area where it was able to safely deploy a Global Position System (GPS) projectile. The projectile allowed the OPP Provincial Communications Centre (PCC) in London to safely track the movements and location of the truck and trailer, without any police involvement as it proceeded towards Waterloo and then became stationary. The Waterloo Regional Police were then contacted and short time later, the stolen trailer was located exactly where it was tracked to. The trailer had been stolen from a Line 14, Perth South address.


# Looking Forward

#### Dear Brent Kittmer:

On January 1, 2015, the Ministry of Community Safety and Correctional Services (MCSCS) implemented a new billing model to recover the cost of policing services provided by the Ontario Provincial Police (OPP). The new billing model was implemented to provide a fairer and more transparent way to calculate billings to municipal governments that receive policing services from the OPP.

The ministry and the OPP have been monitoring the implementation of the new model since it was introduced. As part of our ongoing engagement with the municipal sector, we have heard that there are concerns with the inclusion of some types of properties in the count (e.g., wind turbines) that the OPP uses to allocate base services costs among municipalities.

The OPP has been working closely with the Municipal Property Assessment Corporation (MPAC) on a comprehensive review of all property and structure codes used in the billing model. Based on this review, the OPP has identified several structures and property codes that could be removed to ensure that the properties used to allocate base services costs are appropriately linked to the required level of policing. Specifically, this includes removing properties:

- That do not require proactive policing because they have limited interaction with the public (e.g., wind turbines, communication towers, billboards); and,
- That are considered part of a larger infrastructure system (e.g., tunnels, bridges).

In total, the OPP identified 4,318 properties that could be excluded from the property count based on the above characteristics (see Appendix for a detailed list of property and structure codes). Excluding these property and structure codes from the 2018 Annual Billing Statements would improve the transparency and fairness of the billing process. However, this change will not impact the overall cost of OPP services province-wide, which is fixed to provide consistency for municipal governments year over year. Accordingly, any changes to the number of properties will shift the costs among the OPP serviced municipalities; these costs will not be removed from the billing model.

If implemented, these changes are expected to have a minimal impact on the overall cost for the vast majority of municipalities - for example, roughly 70% of municipalities would experience less than a \$1,500 increase or decrease in their overall cost. Based on the 2017 billing data, the changes being proposed, if implemented, would result in an estimated adjustment of \$1317 in your municipality's 2018 OPP Billing Statement.

The ministry has had discussions with the Association of Municipalities of Ontario (AMO) on the possibility of amending the property count methodology used to calculate OPP billing costs. AMO recommended that the ministry consult more broadly with municipalities policed by the OPP to seek input on whether to proceed with changes to the property count methodology as it will have different impacts for each municipality.

We know that the affordability of the billing model is important for municipal governments. This is why we want to work closely with you and seek your input on how to move forward with this proposal. We are proposing a two-phased approach to engage municipalities:

- Phase One: Using this link <a href="http://fluidsurveys.com/surveys/ontario-mcscs/opp-billing-model-survey/?code=w6cvdsrrpq">http://fluidsurveys.com/surveys/ontario-mcscs/opp-billing-model-survey/?code=w6cvdsrrpq</a>, municipalities are encouraged to fill out a survey that seeks feedback on whether to exclude the properties identified above. The survey will be open until June 30, 2017. Results of the survey will be communicated to municipalities once completed.
- Phase Two: The ministry will work with AMO and member associations, to establish a
  Technical Table with municipal representatives, reflective of the diversity of OPP policed
  municipalities (e.g., contract, non-contract, rural, urban, small, medium), as well as
  representatives from MPAC. The Technical Table will review the proposal and results of
  the survey and provide advice to the ministry on how to move forward.

Should discussions result in changes to the way that municipal policing costs are calculated, the ministry and the OPP will communicate the changes to impacted municipalities well in advance of the municipal budgeting cycle for 2018 to ensure municipalities have adequate time to plan for any changes.
