### 8.1 Monthly Policing Statistics

S. Pilon and S. Bentley reviewed the report and answered questions of the committee.

Member Stam inquired as to the increased use of methamphetamine in the County. In response, S. Pilon indicated that this has been the historic drug of choice in Perth County. The OPP have actively worked on this issue, and have established the "Meth Task Force". The OPP efforts have reduced the usage of the drug, but it has not been eradicated.

S. Bentley indicated that fentanyl is viewed as the next emerging issue for drugs in the County. All OPP officers are now trained on administering naloxone.

Member Stam inquired on car thefts. S. Bentley responded that the significant majority of vehicles stolen in Perth County are those that have the keys left in them. The OPP has implemented education campaigns because almost all thefts are preventable.

It was:</li> <li>An assault between two students where charges were not preferred by the student</li> <li>PC McLeod attended the Committee of Youth Officers Conference in Niagara Falls this month. She heard presentations on Youth Mental Health issues, Youth and Legalizing Marijuana and Youth Trends. The information sessions were all very informative, especially regarding the youth trends. Youth trends spoke about the use of social media including sexting trends and trends in risky youth behavior. Some of the behavior included substance use/abuse and the desensitization of sexual activity.</li> </ul>
Community Mobilization Officer:	The second year of the Community Mobilization Program in Perth County has begun and we are continuing to move forward in providing assistance to residents in our communities. PC Dekoning has continued to attend regular Situation table meetings and recently presented a referral to the group. The subject referred is dealing with addiction issues and will be facing housing issues in the near future. PC Dekoning also spoke to the subject's family doctor communicating concerns to him regarding the subject's current state. As a result of the referral, the subject was provided with a number of community partners and their contact information to assist them. Though it is ultimately up to the subjects who are dealing with issues to get help, PC Dekoning often provides them with all the information to obtain assistance.

	PC Dekoning has been maintaining a presence in the homes within Perth County that provide housing and daily assistance to individuals that are not capable of living independently. Mental health issues are the main reason the residents require assisted living. Police often become involved in calls for service involving the residents from calls being initiated by staff at the homes or the residents themselves. PC Dekoning has developed a positive relationship with the management of these homes in an attempt to offer additional assistance and to provide an element of accountability from a Police perspective. PC Dekoning has been welcomed in to the four homes within Perth County and attends these locations on a regular basis.
	Officers in Perth County had been dealing with a youth continuously over the previous number of months. The calls for service were escalating to an almost daily occurrence which included the Police apprehending the youth under the Mental Health Act and transporting them to the local hospital. PC Dekoning had also been involved with the youth and their family and attended meetings with other community partners that are also involved. Police played a major role in the youth eventually being removed from the home as their family could no longer safely care for them. PC Dekoning and Sgt Bentley spent an entire shift at the home with the youth and their family. A number of agencies were contacted and the youth was eventually removed from the home by the Children's Aid Society. Incidents that conclude in this manner are very difficult but during this process, it was evident that PC Dekoning had successfully built positive relationships with the social agencies involved.
	PC Dekoning has begun his anti-opiate presentations in North Perth. They are being presented in conjunction with Choices for Change. A media release will be sent out shortly and further presentations throughout the county will be scheduled.
	Police investigated nine Mental Health Act calls in St. Marys during the month of February, up from four in January.
