Re: Theft of Copper and Other Metal Products

As you may be aware, the City of Sarnia has recently been plagued by a rash of theft of copper and brass products from City infrastructures, including the recent brazen attempted theft of live high voltage wires from a city facility. Not only is the stealing of these products illegal, it places a great strain on our City's resources that must be invested to replace the stolen items, and can result in serious injury or death by electrocution of the perpetrators.

These thefts can also lead to significant negative impacts to the reliability of services that are caused by power surges, fires, explosions or outages and unnecessarily jeopardizes the safety of the public and City employees when the theft unnecessarily compromises the functionality of any protective safety devices that may have been present.

We ask for your collaboration to help eliminate this dangerous and costly activity by reporting to local police when you notice any unusual activities surrounding the theft or sale of copper or brass products by individuals and help us spread the word about the deadly consequences that may result from trying to steal copper.








