PURPOSE

This report presents the 2020 policing budget reconciliation to CPAC for information.

RECOMMENDATION

THAT ADMIN 25-2021 2020 Policing Budget Reconciliation be received for information.

BACKGROUND

The agreement for service with the Stratford Police Service sets out that the Town of St. Marys is responsible to pay the City for all costs associated with policing in St. Marys. The agreement specifies that some annual budget costs are to be paid as fixed costs, and others are to be paid as reconcilable costs:

9. The Town shall pay the City to provide police services to the Town.

10. The Town shall pay the City a fixed amount for the following costs in accordance with the Cost Estimate. For greater certainty, there shall be no reconciliation or other adjustment to the fixed amount of the costs set out in this paragraph:

- (a) Personnel Costs the fixed amount set out in the Cost Estimate and referred to as Part Time Salaries and Wages, Part Time Benefits and Payable EAP for the cost of wages, benefits and allowances for the part-time police officers required to provide the Contracted Services;
- (b) Support Costs the fixed amount set out in the Cost Estimate and referred to as Support Costs for supervisory and support personnel, including staff sergeants, sergeants, communicators and recording clerks; and

(c) Operating Costs – the fixed amount set out in the Cost Estimate and referred to as Operating Costs for all operating costs not covered above, including administrative support, investigative support, Emergency Response Unit, canine, community services, training, criminal investigations, street crime unit, special victims unit, prisoner meals, police vehicle leases, police vehicle maintenance, general supplies and equipment, Bell Private I.P. Radio, and legal services.

11. The Town shall pay the City a reconcilable amount for the following costs in accordance with the Cost Estimate:

- (a) Personnel Costs The reconcilable amount set out in the Cost Estimate and\ referred to as F.T. Salaries and Wages and F.T. Benefits for the cost of wages, benefits and allowances for the full time police required to provide the Contracted Services;
- (b) Capital Costs the actual cost to the City or any equipment or upgrades required to provide the Contracted Services, or the Town's share of the actual cost if the capital cost is shared; and
- (c) Special Services Costs the actual cost to the City of any service required to provide the Contracted Services which the Stratford Police Service is unable to provide internally, or the Town's share of the actual cost if the special service is shared.

In terms of annual reconciliation, the contract sets out the following approach to be used:

20. After every year for which this Agreement is in effect, the City shall provide the Town with a Reconciliation Statement showing the actual amount incurred by the City for the full time salaries, wages and benefits for the entire Stratford Police Service. The Town agrees that it will be responsible for 8.7% of the actual amount incurred for full time salaries, wages and benefits for the entire Stratford Police Service. If 8.7% of the actual amount incurred is greater than the amount set out in the Cost Estimate, the Town shall make a payment to the City in the amount of such difference. If 8.7% of the actual amount incurred is less than the amount set out in the Cost Estimate a payment to the Town in the amount of such difference.

This approach to reconciliation was chosen to simplify the process and to reduce the administrative burden on the Stratford Police Service so they would not have to keep a line-by-line account of costs.

FINANCIAL IMPLICATIONS

The 2020 reconciliation statement is attached to this report. Within the statement, the Stratford Police Service has indicated the Town will receive a reconciliation payment of \$35,542.20 for 2020. This follows a reconciliation payment of \$35,789.27 in 2019.

Reconciliation payments are places in the Town's policing reserve to fund future capital purchases and operating budget deficits.

PREAMBLE

Since November 5th, 2018 the Stratford Police Service has been providing contracted policing services to the Town of St Mary. In order to meet the needs of the Town, the service has hired five officers for community and patrol operations. As part of the service agreement an annual review of the Full Time Staffing costs is to be completed. Variances in the form of a Full Time Salary surplus or deficit are to be determined and reconciled accordingly.

ANALYSIS

St Marys Full Time salary contribution is determined at 8.7% of the Stratford Police Service budget. Therefore the reconciliation process will require that the final 2020 Full Time salary position be determined. A rate of 8.7% is applied to the final Full Time Salary budget surplus or deficit as applicable.

For the 2020 Stratford Police Service budget, a new "Premiums" line was added to better track overtime and other related costs. The "Premiums" line covers other additional cots relating to Full Time Salaries. The 2020 Full Time Salary budget allocation for the Stratford Police Service was \$8,932,450 in addition the "Premium" line budget allocation was \$367,967 for a total Full Time Salary Budget of \$9,200,417. At year end there was a combined total surplus of \$408,531. Accordingly and by applying 8.7% to this amount a total of \$35,542.20 is owed back to the Town of St Marys.

For the budget year of 2020 there were no Special Services Costs or Capital Costs that required reconciliation.
