INFORMATION

This report provides information to the Heritage Advisory Committee for their review of a Heritage Grant Application for 84 Water Street South.

RECOMMENDATION

THAT DCS 15-2022 84 Water Street South Heritage Grant report be received for information, and;

THAT the Heritage Advisory Committee recommends approval of a Heritage Grant for the application, as submitted, for 84 Water Street South in the amount no greater than \$7,500.

BACKGROUND

84 Water Street South is designated under Part IV of the Ontario Heritage Act. While it is not in the Heritage Conservation District, it is immediately adjacent to the District and still falls within the Central Commercial District. The Heritage Property Grant is open to all designated properties within the Central Commercial District, regardless of whether they are designated under Part IV or Part V.

The owners of 84 Water Street South are undertaking a multi-year project to renovate the building. In 2021 they were a successful applicant of Heritage Grant funding for raising the upper-level ceilings to expose the full height of the windows, replacing the window on the centre of the front façade that had been covered, scaping, caulking and painting lover level windows and doors that were not being replaced.

REPORT

The applicant is requesting grant support for the following work:

• Replacement of ten windows along the north and south sides of the building. This includes all windows on the south side of the building and three of the four windows on the upper north side of the building. These windows will be the same as the wooden windows what were installed on the east façade of the building in 2021.

Section 2n of the grant states that eligible work includes:

• Repair or replacement of wood windows to match the original size, shape, form, and materials. Aluminum storms and windows which are vinyl, aluminum, or PVC clad will not be eligible.

The scope of this work was recommended for Heritage Permit approval by the Heritage Advisory Committee at the April 12, 2021 meeting.

SUMMARY & IMPLICATIONS

A Heritage Property Grant may cover up to 50% of eligible project costs, to a maximum of \$2,500 for painting projects and \$7,500 for other restoration projects.

As the quotes submitted for this project exceeds \$15,000, the project is eligible for the maximum amount of \$7,500.
