# 1. CALL TO ORDER

#### 5. **REPORTS**

#### 5.1 CRIME STOPPERS REPORT

Chief Skinner presented the February 2022 report.

In response to committee members, the Chief confirmed that some tips would be related to COVID violations in circumstances where the caller wished to remain anonymous.

#### 5.2 POLICE MONTHLY STATISTICS

Deputy Chief Foster presented the March monthly statistics.

In response to committee members, the Deputy Chief confirmed that: the "Public Order Maintenance" category is a catchall for a number of calls related to disorder; that one "youth diverted" relates to a break-in at the high school, and that further review would be needed to determine if the trend of four (4) calls is concerning.

The Chief provided an update to the committee on a number of successful grants totaling over \$1M in the policing budget to: expand MCCRT service in the region; to provide a one-year pilot for a mental heal coordinator position; and to support a program to hire part time casual officers to be called in a peak service times.

In response to committee members, the Chief confirmed that the candidate pool for the casual positions will likely be retired officers due to the need to have an Ontario Police College certificate.

Chair Diplock thanked the police service for issuing a press release related to the need to still renew license plates.

### 6. OTHER BUSINESS

### 6.1 2022 Policing Operating Budget & 5 Year Capital Plan

Brent Kittmer presented the 2022 policing budget member.

In response to committee members, Chief Skinner and Deputy Chief Foster confirmed:

- the costs for EAP have increased due to increased usage, and an increased benefit negotiated with the SPS PSA;
- that Maintenance Contracts have increased due to cost, and due to bundling other budgeted items into this line item;
- that the SPS receives standardized pricing from dealerships for cruisers, that the St. Marys Ford dealership is eligible to provide pricing, and that St. Marys Ford has provided unmarked vehicles to the SPS; and
- that the NG911 transition is a next generation transition mandated by the CRTC to be completed by 2024.

# 6.2 Road Network Safety Plan Update: B. Kittmer

Brent Kittmer presented an update on the road network safety plan.

In response to committee members, Mr. Kittmer confirmed that the Town is not aware that Vision Zero has received royal assent and that the Road Network Safety Plan will be a St. Marys specific adaptation of the principles of Vision Zero.

# 6.3 Legislative Amendment for Fees for Police Record Checks for Volunteers

Deputy Chief Foster presented an overview of the legislative amendment for the elimination of fees for police record checks for volunteers.

Deputy Chief Foster outlined that the Province has mandated police to provide free volunteer checks, but this does not include vulnerable sector checks. Mayor Strathdee noted that provincial press releases make it appear as though all volunteer checks are now free and encouraged there to be additional press communication by the police to clarify what is and is not free.

# 6.4 Register a Bike (529 Garage)

Chief Skinner presented and outlined that the current system of the police storing and auctioning of stolen and lost bikes is a cost to the police service. 529 Garage is an online program the police will be launching where bike owners can register their bike after purchase, and then search for reports of its description if it is lost or stolen. The police are launching this program as a strategy to reduce police involvement and will be evaluating its success. In response to committee members.

Chief Skinner confirmed that the database is privately operated and that although it is searchable, a person would not be able to seek out personal information of bike owners. 300-400 bikes are reported lost or stolen each year. The database has an international breadth and extends into the US. The SPS Communications is communicating this service to other police departments in the area.

# Excerpts from Traffic, Parking and Boulevard Maintenance By-law, 58-2018

3.1(3) No person shall Park a Vehicle in any of the following places during the specified times:

- o) on a Highway between 2:00am and 6:00am from November 1 until April 30;
- p) on a Highway for a duration longer than 72 hours from May 1 until October 31;

#### 3.2 Parking Restrictions on Specified Highways

- (1) No Parking areas are set out in Schedule 10 hereto.
- (2) No person shall Park a Vehicle on any of the Highways or portions designated no parking areas.
- (3) On-street parking areas with a three (3) hour parking limit are set out in Schedule 11 hereto.
- (4) No person shall Park a Vehicle for longer than three hours in designated areas.
- (5) No person shall Park a Vehicle in the downtown boundaries as identified in Schedule 4 between 2:00am and 6:00am, year round.
