#### BY-LAW 10-2023

#### THE CORPORATION OF THE TOWN OF ST. MARYS

Being a By-law to confirm all actions and proceedings of the Council of the Corporation of the Town of St. Marys at its special meeting held on February 7, 2023.

- WHEREAS: The Municipal Act, 2001, S.O. 2001, c.25, as amended, Section 5(3), provides that the jurisdiction of every council is confined to the municipality that it represents, and it powers shall be exercised by by-law;
- **AND WHEREAS:** The Council of the Corporation of the Town of St. Marys deems it expedient to confirm its actions and proceedings;
- **NOW THEREFORE:** The Council of The Corporation of the Town of St. Marys enacts as follows;
  - 1. That all actions and proceedings of the Council of the Corporation of the Town of St. Marys taken at its special meeting held on the 7<sup>th</sup> day of February 2023 except those taken by by-law and those required by by-law to be done by resolution are hereby sanctioned, ratified and confirmed as though set out within and forming part of this by-law.
  - 2. This by-law comes into force on the final passing thereof.
