

Subject: LIB 20-2024 Library Budgets Cuts

## **PURPOSE**

To provide the library Board with recommendations on how to recover the loss of funding from Perth South in the current 2024 budget as well as the upcoming 2025 draft budget.

## RECOMMENDATION

THAT LIB 20-2024 Library Budgets Cuts report be received; and

**THAT** the Library Board approve the adjustments to the 2024 and 2025 Library Budgets to reflect the loss of funding from Perth South as detailed, including services level changes to Thursday and Saturday hours.

# **BACKGROUND**

The St. Marys Public Library will not, as of May 2nd, 2024, be providing library services to Perth South residents through a service agreement for the 2024 year. The service agreement funding request which was put forward in January to their Council and was included in the library's budget calculations was for \$74,363. The Library provided Perth South with library services from January 1 to April 30, and we received a payment for these services on May 28, 2024, totalling \$24,787.68. To have a balanced budget without the full funding from Perth South, the budget will need to reflect the loss of \$49,576 in funding.

#### REPORT

Staff make the following recommendations to the budget lines to achieve this balance. It is important to note however, that calculations for 2025 do not account for inflation and COLA.

#### **SUMMARY**

Budget cuts are required in the absence of our long-standing service agreement with Perth South for the 2024 and 2025 budget years and staff have made the following recommendations to accommodate this budgetary change for the Library Board's consideration.

Subject: LIB 21-2024 Library Services to Perth South Students

## **PURPOSE**

To discuss the termination of a service agreement with Perth South and the impact this has on library use within the county.

#### RECOMMENDATION

THAT LIB 21-2024 Library Services to Perth South Students report be received; and

**THAT** the Library Board continue to support Perth South students who do not attend school in St. Marys by allowing access to our collection with a non-resident Stratford student card, OR

**THAT**, in light of the funding cut from Perth South Council, and its impact on the Library's operating budget, St. Marys Public Library Board will rescind free access to the St. Marys Public Library by Perth South students who do not attend schools within St. Marys or any PCIN members' schools until a service agreement is reached.

#### **BACKGROUND**

Prior to the pandemic, the St. Marys Library, in partnership with other PCIN libraries, launched a campaign to encourage students within Perth County to get a library card and use libraries. Class visits were organized, and each child was offered their own library card. The "Kitcard" campaign to increase of and awareness of libraries to students and their families within Perth County continued with class visits each year until the pandemic, and then resumed again as schools allowed community partners back into their schools. St. Marys Public Library staff have traditionally visited elementary schools within the Town and extended our visits to Perth South Collegiate. However, following the abrupt end to funding this year, the Library Board decided to only extend library access to Perth South students who attend school within the Town's boundaries, so visits to Perth South Collegiate are on hold until a service agreement is in place.

#### REPORT

Staff are seeking direction from the Library Board to address Perth South students who do not attend school in St. Marys and whether, once revisiting the aims of the Kit Card program, the Board wishes to finetune or revise their motion regarding access to the traditional library collection. If the Library Board decides to continue to provide access to the library to all PCIN students, it would not include access to programming unless the board wishes to include that element of our services. Also, as a further note, PCIN has determined that students will have access to PCIN resources, including e-collections owned by PCIN (Download Library, PressReader, Pronounciator).

# **FINANCIAL IMPLICATIONS**

Staff time, operating costs and collection costs are paid by the St. Marys Public Library and currently there are no funds provided by the municipality of Perth South to cover these extension of these services.
