





BEAUTIFICATION OVERVIEW 2023

- 25% rebate back to shop/building owners for spring and summer flowers outside their storefronts
- Fall-themed packages through the downtown
- Facade installed to conceal the now empty Baseball Hall of Fame office (aka "selfie station")
- Disguised the look of empty storefronts on Queen St with Fall and Christmas-themed decor
- Decor pots on Queen St out right through until after the holidays
- Provided holiday wreaths + ribbon to each business downtown
- Decorated bridge with holiday garland
- Contribution to Town's pots and flowers

SPRING/SUMMER 2023

- Contribution to Town's pots and flowers
- 25% rebate back to shop/building owners for flowers outside their storefronts
- Shop owners encouraged to provide decor with moderate success of 17 participants
- Total spend for this initiative approximately \$800



FALL 2023

- Thanks to Public Works Dept and mild fall weather the pots stayed out on Queen St.
- Fall-themed street decor included hay bales, pumpkins, corn stalks
- Cost approximately \$3000
- Capitalizing on the small town charm, remained an inviting draw for tourists and locals









WINTER 2023

- Wreaths + ribbon provided to each business
- Bridge adorned with garland
- Shooting stars lights installed
- Planter pots filled with holiday decor to end of holiday season
- Selfie-station decked out for holiday season







SELFIE-STATION 2023



- A facade installed to conceal the now empty Baseball Hall of Fame office
- This "selfie station" is a fun opportunity for tourists and locals to post themselves on social media and tag Downtown St. Marys
- Decorated seasonally
- One time installation cost was approximately \$1500
